MANAGEMENT REPORTS

a. 2021 Washington County Recycling Grant draft projects

Ms. Reidlinger shared three topics that would be included in the 2021 grant cycle and is looking for feedback prior to submitting the application.

- 1. Promote Washington County's organics composting program
- 2. Promote Washington County's BizRecycling program
- 3. Promote residential recycling through simple high-level education

In response to a question from Commissioner Wilson, Ms. Reidlinger shared the Edge Newsletter goes to a limited audience. The Oakdale Update would be used for broader messaging.

In response to a question from Chair Miller, Ms. Reidlinger noted the EMC would have a cross promotional opportunity at the Oakdale Farmer's Market to highlight the benefits of composting via a table with flyers which was to be discussed for finalization.

b. 2021 renewable energy policy and implementation

Chair Miller opened up the discussion by noting that renewable energy is in the Oakdale 2040 Comprehensive Plan; currently the City uses Solar for electricity.

Ms. Reidlinger shared her memorandum with the Commission regarding renewable energy and where to focus efforts in 2021. Solar is one area already discussed, and Ms. Reidlinger is looking for other priorities to address as well. She noted two specific 'call-outs' in the 2021 EMC Work Plan: host a Solar Twin Cities Power Hour and to host a Citizens Utility Board (Cub) Clinic for Utility Bills.

Commissioner Wilson mentioned promoting Wind Energy through the Wind Source by Xcel Energy.

Chair Miller shared that the Midwest Renewable Energy Association would be doing the Solar Twin Cities Program. He explained this program typically starts late May, early June and is wrapped up in October.

Chair Miller shared another suggestion regarding Community Solar Gardens that are taking subscriptions. This would allow residents without assessable personal solar use to participate. He suggested that if we find open subscriptions in surrounding areas, we make this a social medial post to alert residents and businesses.

Chair Miller noted connecting with developers and businesses to educate about renewable energy financing options is another avenue.

Ms. Reidlinger summarized this discussion by noting four action items:

- 1. Participate in the Solar Twin Cities Programs
- 2. Obtain information on Solar Gardens available to Oakdale residents and promote.
- 3. Informing developers and business of opportunities to install solar equipment.
- 4. Research the Xcel Wind Source Program and promote.

OTHER ITEMS

a. Editorial Calendar review

The Commission discussed the Editorial Calendar.

Commissioner Wilson suggested noting environmental items on the front page of the Oakdale City webpage. She also wanted to highlight Earth Day.

Commissioner Gerding noted that April has national volunteering month and week. Adopt-A-Drain program would be one to promote from the EMC.

b. Willowbrooke Development

Chair Miller contacted the Willowbrooke developer and was told that when a Property Manager has been assigned they would contact him to discuss EMC concerns.

CITY COUNCIL UPDATE

Council Member Kevin Zabel electronically shared his updates:

- a) Council Member Zabel will discuss with Council a possible ordinance, if there is interest in multi-family units offering recycling for their residents
- b) The Council would like to remind the EMC to think about their 'budgetary asks' for 2022 and think about projects that will require funding.

Chair Miller shared ideas for funding for next year and asked the Commission to bring ideas to April's meeting.

Commissioner Kantola reminded the group about the Arbor Day Tree giveaway.

Commissioner Gerding thanked Commissioner Kantola for going on the broadcast of Oakdale Update to inform the public of not only the Arbor Day Tree giveaway, but also other City programs. He also shared that he was working on single-use plastics and discussing with other cities.

SUBJ: GreenStep Cities metrics

In order to maintain its Step 4 & 5 designation with the Minnesota GreenStep Cities program in 2021, the City is required to submit an annual report on key sustainability metrics. This memorandum summarizes those reported metrics.

Minnesota GreenStep Cities is a voluntary challenge, assistance, and recognition program designed to help cities achieve their sustainability and quality-of-life goals. The free, continuous improvement initiative is based upon 29 best practices that are tailored to Minnesota cities and encourage civic innovation. The 29 best practices focus on cost savings and energy use reduction.

The City of Oakdale was awarded Step 5 designation in 2020. To maintain this designation, the City is required to document and demonstrate improvement on Step 4 metrics. A summary of selected core metrics reported for 2021 is as follows:

SUBJ: Multi-family dwelling recycling opportunity assessment

This memorandum highlights the City's multi-family dwelling recycling priorities for the purpose of generating discussion about the potential policies implementing those priorities. The City's overall policy regarding recycling is defined in the 2040 Comprehensive Plan and implemented by Chapter 6 of the Code of Ordinances.

2040 Comprehensive Plan

The City's role is to build a more resilient community by supporting and facilitating the conservation of natural resources that make a functioning society possible for future generations. Recycling is one method of practicing natural resource conservation. As stated in the 2040 Comprehensive Plan, the City's goal with regards to recycling is to "promote and encourage strategies that reduce waste generation and increase options for reuse, recycling, and composting of items in City operations, residential and commercial developments" (Chapter 8, Goal 1, Policy 7).

Chapter 6 of the Code of Ordinances

While encouraged by the City's Comprehensive Plan resiliency policy, recycling is voluntary in Oakdale (Code of Ordinances, Chapter 6, Sec. 6-12[d]). To support voluntary recycling activities, waste haulers licensed by the City are required to provide single-sort recycling service to all residences regardless of dwelling type (Sec. 6-24 [b]); however, the recycling habits of Oakdale residents may vary. For example, while residents in single-family homes can collect recyclable materials in an easily-accessible, hauler-provided container, those in multifamily dwellings like an apartment might experience more difficulty in moving recycling from their unit to a community collection bin.

Opportunity assessment

To encourage increased voluntary recycling activities in Oakdale multi-family dwellings, City staff will conduct an opportunity assessment of multi-family recycling. The goal of the opportunity assessment is to determine the issues related to recycling that are unique to multi-family dwellings. The outcome of the assessment will be a recommendation, drafted by the EMC, for new or updated policy regarding multi-family recycling.

The opportunity assessment will be conducted in three phases.

1. Phase One: Evaluate current conditions and identify opportunities for improvement.

The objective of Phase One is to increase the EMC's understanding of current recycling rates and barriers for residents in Oakdale's multi-family dwellings. Findings from this phase may encompass:

- a. Current recycling activities (by both residents and property managers of multi-family dwellings), including collected tonnage
- b. Current and past initiatives to increase recycling in multi-family dwellings
- Obstacles to supporting and/or participating in recycling collection at multi-family dwellings

2. Phase Two: Create actionable goals and a policy to achieve those goals.

The objective of Phase Two is to develop draft goals for improved multi-family recycling. In addition to the findings from Phase One, the EMC will consider Oakdale's Comprehensive Plan as well as multi-family recycling best practices (presented by staff) to identify goals and generate policy recommendations.

3. Phase Three: Implement developed policy and monitor effectiveness.

The objective of Phase Three is to implement drafted policy and measure progress towards the EMC's identified multi-family recycling goals. Phase Three will begin with a presentation by the EMC and staff of opportunity assessment findings, as well as a draft policy and implementation plan, for City Council review. Achievement of the goals identified by the EMC in Phase Two will then be monitored throughout Phase Three to increase awareness of the efficacy of multi-family recycling policy implementation.
