Bid Rejection for City Project U2022-04; Water Tower 2 Painting (3888 Hadley Avenue North)

a) It is requested that Council reject Classic Protective Coatings, Inc. and re-bid later this year.

City Administrator Volkers explained that the bid received from Classic Protective Coating, Inc. is 21% - 24% higher than the Engineer's estimate and suggested rejecting this bid due to lack of available funding and hold off until February 2023 and re-bid the project.

Mayor Reinke supports the rejection of the bid, having nothing to do with the contractor or character of the contractors, but solely based on the fact that the bid is significantly higher than what is budgeted for the project.
